The publications of the International Court of Justice are issued in several series.

Reports of Judgments, Advisory Opinions and Orders. This series contains the Reports of the decisions of the Court in both the English and the French texts. Each decision is published as soon as given, in an unbound fascicle which is sold separately. To allow for binding, a system of continuous pagination is adopted for all the fascicles of any one year.

At the beginning of each year, an analytical index is published of the previous year's decisions; this also may be purchased separately. The collected decisions, with index, for each year may also be obtained ready bound together in one or more cloth-bound volume(s). (See pp. 61-64, *infra*.)

For the decisions relating to any particular case it will generally be necessary to refer to several volumes. (See the Alphabetical Index, pp. 65-73, *infra*.)

Pleadings, Oral Arguments, Documents. Volumes in this series are published as soon as possible after the termination of each case and contain the documentation relating to the case, in the original language, that is, in English or in French. These publications are divided into three parts: the document instituting the proceedings and the written pleadings; the verbatim record of the oral proceedings; any documents submitted to the Court after the closure of the written proceedings. One or more volumes are issued for each case. (See the Alphabetical Index, pp. 65-73, *infra*.) The volumes which appeared up to 31 December 1964 (up to Sales No. 286) are sold in cloth-bound form whereas subsequent volumes are in paper covers.

Acts and Documents concerning the Organization of the Court. Six (bilingual: French and English) volumes have appeared in this series. The first contains the Charter of the United Nations, the Statute of the Court, the Rules of Court adopted

in 1946 and other constitutional texts and regulations (Sales No. 2). The second contains the Rules of Court as amended in 1972 (Sales No. 364). The third contains the Charter of the United Nations, the Statute of the Court, the Rules of Court as amended in 1972 and other texts (Sales No. 428). The fourth contains the Charter of the United Nations, the Statute of the Court, the Rules of Court adopted in 1978 and other texts (Sales No. 437). The fifth contains the same documents as the fourth, with some corrections and an additional resolution concerning a State entitled to appear before the Court (Sales No. 575). The sixth volume, as amended in 2007, contains the forementioned documents along with Practice Directions, the Resolution concerning the Internal Judicial Practice of the Court, certain documents relating to the States entitled to appear before the Court and to the Court's privileges and immunities (Sales No. 917). The first volume is sold in cloth-bound format; the others are in paper covers.

Annuaire-Yearbook. Each year a *Yearbook* is published in which an account is given of the work of the Court during the period from 1 August of the preceding year to 31 July of the current year. This publication, previously produced in two editions (one in English (*Yearbook*) and one in French (*Annuaire*), is now published in a single bilingual edition. Bibliography of the International Court of Justice.
